Hartley House is accredited by the Social Security Administration (SSA) as an Organizational Representative Payee for HOPE clients, the basis of its Formal Money Management (FMM) component. HOPE manages its clients as full representative payees. These clients have significantly reduced their incidence of elder financial abuse, reduced their debt, prevented their monthly bills from ending up in arrears, and prevented possible eviction – delaying early institutionalization.

The Home Outreach Program for Elders (HOPE) remains a critical priority for Hartley House and a critical source of support for low-income and vulnerable seniors residing Hell's Kitchen. HOPE provides wrap-around case management, Formal Money Management services, benefit assistance and support. HOPE continues to increase its programmatic effectiveness and capacity. These services are necessary for older adults to age safely and with dignity in their own homes.

In 2019, that team has served 103 clients, increased Formal Money Management enrollment by two clients, and provided stipendiary assistance to 26 clients for a total of \$8,877 per month. In addition, HOPE Secured \$34,510.00 in monthly benefits, including: SNAP -\$9,852 for 61 clients; SSI - \$14,562 for 29 clients; Medicare Savings

## CHILDREN AND YOUTH SERVICES

Hartley House's After School Program provides children a safe and warm environment where they are encouraged to develop their academic, creative, and leadership skills through a project-based Learning Community (LC) design, taught by a dedicated staff. The Learning Community model that incorporates literacy, creative arts, STEM, mentoring and life skills. In 2019 Hartley House's After school Program served 75 participants. Each month of program is dedicated to a different theme. Based on these monthly themes, staff creates lesson plans that correlate with these themes. Growing Responsibly and Delivering Services (GRADS) is a program designed to offer valuable volunteer opportunities and leadership development for students aged 13-18, or who have aged out of the After School and Summer Camp programs. In 2019, Hartley House served five GRADS, a pathway to employment at the House: over 50% of paid counselor positions are filled by former GRADS each year.

In 2019, weekly BINGO was moved back to our location on 46th Street. Since moving back to Hartley House, weekly BINGO has resumed every Tuesday afternoon. We have about 45-50 participants attend Bingo. Hartley House has also hosted Movie Nights and a Music Concert for the community and HOPE clients, resuming beloved and critical socialization for potentially isolated seniors.

We invited guest speakers to present on completing the 2020 Census.

In 2019, HOPE assisted 25 Bingo participants from our weekly Bingo in completing NYC-210 and IT-214 Tax credit forms.

We have resumed volunteer opportunities which companies such as Kenneth Cole since moving back. Hartley House hopes to broaden these opportunities and increase the number of organizations and volunteer along with the amount of time spent with Hartley House each year.
